**Return instrument to Arlington Strings OR Renewal of Contract must be done by June 15th 2021.
Failure to do so by June 15th 2021 will result in late charges beginning June 16th 2021.
Late Charges are per month: Violin/Viola \$15, Cello \$30**

YEARLY RENTAL: as listed at top of page is the payment for the 9-month school year. Rental term is from the first to last day of the school calendar year for 2020-2021. Renter must return all rented property or re-rent instrument by **June 15, 2021**.

TERMS: Rental is by school year basis. This contract may be terminated at any time by the return of all rental property in good condition & with rental payment paid in full. Rental price includes insurance for basic wear and tear. **BASIC WEAR AND TEAR** includes: replacement of broken strings, bow, broken bridge, case, and malfunctioning parts. Arlington Strings may decide, at its own discretion, that damage is not due to normal wear & tear and is due to abuse or neglect of instrument; renter will be responsible for damages beginning at \$75 or actual repair cost if less than \$75, up to full current repair price. **EXAMPLES OF REPAIRS NOT COVERED: new cracks, new breaks at neck or scroll.** Renter will be responsible for the price of one year's full rent in the event of **first time** total damage or loss of instrument. Any **second time** total damage or loss will require renter to pay full replacement value of instrument. **MAINTENANCE & RETURN OF PROPERTY:** Renter agrees to exercise reasonable care during possession of rental property. Upon expiration or early termination of this Rental Agreement, Renter agrees to return the rented property to Arlington Strings. Such property to be in a condition equivalent in all respects to that in which it is received, **NORMAL WEAR & TEAR** excepted. The retail prices of these instruments are: **Basic- violin \$350, viola \$400, cello \$850. Prodigy line- violin \$500, viola \$650, cellos \$1250.**

OWNERSHIP & PURCHASE: The property rented is and shall remain the sole property of Arlington Strings. Arlington Strings does not sell its rental instruments and the Renter shall have no right, title, or interest in the property except as expressly set forth in this rental agreement. Renter may choose to apply pre-tax rental credit toward the purchase of a **new fine** instrument. Offer is valid only if reasonable care of rental instrument has been maintained and all payments made during the life of the rental contract are paid in full.

RENTAL CREDIT: Renter accrues store credit of full annual rental fee for first complete year of renting and 1/2 the annual rental fee for each year thereafter towards the purchase of a **new fine** instrument. All rental fees must be paid in full and current before any store credit is available. Rental credit is non transferable between students, even in the same family.

DEFAULT: If renter defaults in any of the Lease/Purchase payments or removes or attempts to remove the property from the School District in which Renter presently resides (without Arlington Strings written consent) or violates any other terms of this Contract, Arlington Strings may terminate this agreement. In the event of default, Renter agrees to pay to Arlington Strings its reasonable attorney's fees, court cost, and other expenses incurred in the repossession of each property. In case of Renter bankruptcy Renter agrees to return the property to an Arlington Strings representative. **All rental accounts in default will be given to collections Jan. 1 of each year.**

RENTAL RETURN REFUNDS: a full refund is available through **Aug. 31, 2020**. After that date, half of the yearly rental will be refunded through **Dec. 31, 2020**. After **Jan. 1, 2021**, no refunds are available.
